Dear Chairman Maxwell and Commissioners:

In accordance with Section B. Paragraph 2 of Alabama Statute 83-575, the unaudited 2015 Annual Report of the Macon County Racing Commission is hereby submitted.

The total handle for 2015 was \$21,501,045.40 as compared to \$20,768,073.20 for 2014. This figure represents an approximate 0.34% increase.

The 2015 handle was composed of:

5,963,375.70	Simulcast Horse Racing
\$ 21,501,045.40	Total Handle

As in the past, the pari-mutuel industry continues to produce an economic benefit to Macon County and the State of Alabama, but unfortunately, again, it has declined significantly since its all time peak in 1988. Please be reminded that live greyhound racing was discontinued in 2011, which continually causes a significant impact on this tax base.

The Racing Commission appreciates the assistance and support provided by all levels of government. Please know that this Racing Commission will continue to work to insure the future of the pari-mutuel industry in Macon County.

I. MACON COUNTY RACING COMMISSION

A. Introduction

This unaudited report is being submitted to the Macon County Commission pursuant to Alabama Statute 83-575, Section 6, paragraph 2.

B. Constitutional/Legislative Authority

The Macon County Racing Commission was created on September 7, 1983 according to the provision of Act No. 83-575 of the Alabama Legislature. The Racing Commission operates in the public interest and is vested with all powers and duties necessary and proper to insure the integrity of race meetings in Macon County, Alabama; proper administration of pari-mutuel wagering pools and the payment of all fees, commissions, taxes, fines and forfeiture received under Act No. 83-575 and its amendments.

Through its rules, the Racing Commission intends to control and regulate pari-mutuel wagering in connection with live greyhound racing and simulcast horse and greyhound racing.

C. Duties of the Racing Commission

The legislature has empowered the Racing Commission with certain duties including, among others, the authority to:

- 1. Regulate greyhound racing in Macon County, Alabama to ensure that it is conducted in the public interest;
- 2. Issue racetrack operator, kennel operator/owner and occupational licenses;
- 3. Enforce all laws and rules concerning greyhound racing;
- 4. Supervise the conduct of pari-mutuel betting and collect and distribute all pari-mutuel taxes;
- 5. Conduct investigations and inquiries the Racing Commission deems necessary to carry out its duties; and
- 6. Take all necessary steps to ensure the integrity of live greyhound racing and pari-mutuel wagering on live and simulcast racing in Macon County, Alabama.

D. The Commissioners

The Racing Commission consists of three (3) members appointed as follows:

- 1. The current representative from Macon County in the House of Representatives shall appoint one (1) member for a term of six (6) years, the current senator representing Macon County shall appoint one (1) member for a term of four (4) years and the Macon County Commission shall appoint one (1) member recommended by the Macon County Council of Governments for a term expiring the day following the 1984 General Election.
- 2. After the expiration of the term of the initial appointments, each appointment thereof shall be for a term of six (6) years and every six (6) years thereafter successors to this place on the Racing Commission shall be qualified and elected; and
- 3. Upon the occurrence of any vacancy in office, the new Racing Commissioner shall be appointed in the same manner as the original appointment. The Governor, upon recommendation of the legislative delegation representing Macon County shall fill vacancies occurring in the elected Racing Commissioner's place. Racing Commissioners shall be eligible for reappointment.

E. The Racing Commission Staff

The Racing Commission is currently staffed by the following positions/duties:

- **Treasurer**: shall collect the license fees, taxes and revenues provided for in the Act and shall supervise, check and audit the operation of the pari-mutuel wagering pools and the distribution thereof.
- **Secretary/Office Manager**: shall record and maintain all Racing Commission records and serves as its licensing agent.
- Assistant Chief Inspector: shall monitor track operations, make inspections and report on the Association facilities, investigate and respond to complaints filed with the Racing Commission.
- Simulcast Official/Auditor: shall interpret and enforce all Racing Commission Rules regarding simulcast and live pari-mutuel handle in accordance with the Racing Commission procedures.

To further assist the Racing Commission with its regulatory responsibilities, the following individuals were contracted by the Macon County Racing Commission for professional services during the 2001 racing season:

Legal Counsel: shall advise and represent the Racing Commission.

Meetings of the Racing Commission

The Racing Commission meets at 4:00 p.m. on the second Wednesday of each month. Special Meetings are held at the call of the Chairman or a majority of its members.

II. Racing Commission Activities

A. Rulemaking

Of the many duties and responsibilities of the Macon County Racing Commission, perhaps the most important is to promulgate the rules by which pari-mutuel racing and wagering will be conducted. All rules and amendments thereto have served well to regulate and control the industry. Through the events of the past race meets, it remained apparent that several rules, many of them unique to Macon County required certain revisions. Additionally, circumstances arise that indicate the need for additional rules in specific areas. As a result the Macon County Racing Commission reviews and updates its rules to meet the current needs of the industry with the most recent amendments being printed and distributed in January 1998.

B. Licensing

The Macon County Racing Commission must license everyone who is employed at VictoryLand in Macon County.

C. Pari-Mutuel and Financial Statistics

The total handle for the 2015 simulcast meets was in excess of \$ 21,501,045.
